

# MNICS 30<sup>th</sup> Anniversary



MNICS First Annual Meeting, Quadna

Response to wildfire and all hazard incidents in Minnesota changed drastically 30 years ago. What evolved was a unique system that remains a model for others today.

The product is the Minnesota Incident Command System (MNICS), a partnership between several state and federal agencies that coordinates resources, shares facilities, and provides a trained incident response workforce.

MNICS beginnings followed record high numbers of wildfires in Minnesota in the 1970s.

"We had some really bad fire years in the mid-'70s," said Carson Berglund, retired Department of Natural Resources (DNR) wildfire suppression supervisor. "Wildfire agencies nationwide were so busy, that the

Minnesota DNR would bring in people from Oregon and California, while other resources from Minnesota were going out. They'd pass each other at the Duluth airport."

Berglund was one of several people pivotal in creating the partnership. So was Bob Joens, retired US Forest Service fire management officer for the Superior National Forest.

"We had some agreements prior to MNICS, but we couldn't move very far outside of our unit boundaries. MNICS gave us that ability," Joens said.

"Efficient use of resources was one key element in the formation of MNICS. Moving to the incident command system (ICS) was another."

"Fire folks from Boise met with Minnesota fire managers in St.

Paul in 1983 and said we needed to move to ICS.

"Truthfully, many of us rolled our eyes and said ICS would never work," Joens said. "But, we looked at some of the barriers and ways to hurdle them. It took trust, respect, openness and commitment."

Berglund said one of the key elements to success was training. "Training improved the professionalism of wildland firefighters across all agencies.

"One year we had 15 training courses with instructors representing all our member agencies. That would have been impossible without working together under the new system."

Even after creating the partnership, many tasks remained. Interagency overhead teams were formed in 1985, along with the creation of a Minnesota Red Card qualification system for team positions.

In 1986, the MNICS Task Force started meeting monthly as the governing body and hired a coordinator to oversee day-to-day activities.

In 1987, MNICS started joint air operations, leading to the dispatch of 13 interagency helicopter crews to wildfires in California that fire season.

"As agencies cooperated in wildfire and incident management through MNICS, it became clear we needed a coordinated dispatch center," Berglund said. In 1990, MNICS operations moved to Grand Rapids in a combined Minnesota Interagency Fire Center (MIFC). In 1991, MIFC moved to its own building.

Berglund said, "It really is a unique and impressive organization. And, it only gets better."

# Carson Berglund & Bob Joens

MNICS owes its existence to the efforts of many. However, if we were to identify founding fathers,

Carson Berglund and Robert Joens are those two individuals. It was through their insight, energy, dedication, and perseverance that the many obstacles to a multi-agency partnership were overcome.

Thirty years ago, a state and federal partnership on the scale of MNICS was beyond comprehension for most. It was a new concept that would require unique agreements and nervous money management. There were huge issues with regard to credibility and often a lack of mutual respect. There were a lot of hard "no's" to be quashed, but they did it. Sometimes a bit brash, but always professional, Carson and Bob were unique individuals who happened to be on the same piece of ground at the same time and they made the best of it. They brought together the needed pieces to build MNICS.



## **Jeff Haas**

Another key individual in the success of MNICS was Jeff Haas, the first coordinator.

He served prior to MIFC, when there was not a physical site to identify with, only a concept. Jeff was the first voice, convincing and educating skeptics and supporters alike. His role during the infancy of MNICS was large.


Jeff did not stop with advocacy. He remained a primary player with MNICS over the decades, serving as a Plans Chief and Incident Commander on MNICS teams.




# **Paul Tine**

Paul was one of the first people to venture out of state in a leadership role with a contingent of Minnesota mixed-agency resources. Today, we hardly think about multi-agency crews, but in the 1980s, it was a big deal.

In the 1980s Paul worked as a Federal employee during the fire season and with the State in the winter months. As a state employee he went on tour, building support and understanding of MNICS.

Later, when MIFC came into being, Paul served as a fuels specialist. He is recognized nationally for his fuels and fire behavior expertise, and with that came a new level of credibility for MIFC. He brought fire science to MIFC, MNICS and Minnesota.



# Bruce Humrickhouse

For years, other states and Federal agencies have looked to Minnesota for advice on how to build better aviation programs. During the formation of MNICS, aviation was identified as a critical ingredient.

Bruce Humrickhouse provided the leadership to bring state aircraft and pilots into alignment with federal standards. He saw the future of a broad and integrated aviation program, drew the circles on the map initiating the state tanker base program, and provided guidance to bring agencies together on fixed and rotary wing use.

Several names stand out over the years in Minnesota aviation. But, in the beginning, it was Bruce who laid the foundation.

# Air Operations / Air Dispatch



The annual MNICS/Great Lakes Forest Fire Compact (GLFFC) Aviation meeting was held in Brainerd on March 11-12, 2014. MNICS and GLFFC agencies shared procedures, protocols and aircraft rates. Agreements with partners were updated.

The spring fire season was slow. Activity included:

- Two CL-215s, Air Attack and two helicopters worked the Nary Road Fire by Cass Lake
- Two CL-215s, Air Attack, one helicopter, two CL-415s and a Birddog worked the County Road 13 fire by Little Fork
- Two CL-215s, one Air attack, two helicopters, one Beaver flew on the USFS Hwy 46 Fire
- Ontario sent a Quickstrike with two CL-415s and Birddog for northern Minnesota
- Eight exclusive-use helicopters (DNR) were on standby for 42 days this spring and responded to 17 fires with 28 structures threatened
- One exclusive-use helicopter (BIA) supported firefighting and prescribed burning efforts at Red Lake for a total of 45 flight hours in 2014

The Air Operations section of the MNICS website is updated annually and contains hazard maps and aviation plans that provide information on the unique aircraft, equipment, environment, challenges, partnerships, agreements and opportunities in Minnesota.

Dispatch

2014 was a record- setting year for fewest fires in Minnesota: 873 fires for 3, 678 acres.

Dispatch processed and filled 564 out-of-state overhead orders (includes single overhead orders, overhead team members, engine/ equipment crew members), plus 12 equipment orders, 20 engine orders, and eight 20-person T2IA crew orders. (Does not include UTFs, reassignment duplications, cancellations, retrieved orders).

Dispatch sent resources to many types incidents such as: aerial ignition, crew support, preposition, floods, aviation inspections, search and rescue, wildfires, IMT training, State Fair fire prevention, blowdown, FireWise, NFFS Convention.

MIFC Dispatch thanks support dispatchers and dispatchers in field offices. Special thanks to Joan, Cec and Vienna for their tireless work and commitment. Thank you to the MIFC Air Desk and air personnel, intelligence and information staff, duty officers, Forest Service IA Dispatch, cache personnel, radio shop staff, front office personnel, finance and human resources staff, Duluth Mob Center staff, and all the MNICS agencies that provided resources and help this year.





# Intelligence Fire Behavior Public Information





Minnesota had severe storms and large precipitation events during every month from December 2013 through the end of September 2014. These events kept fire incidents to a relative minimum in the state. If Minnesota experiences above normal temperature conditions this winter, it may have an effect on the start of fire season next spring.

For calendar year 2014 through the end of October, MNICS agencies reported 964 fires for 3,986 acres. The 10-year average for MNICS agencies is 1,633 fires burning 51,107 acres. It was a quiet year for fires.

From January 1 through October 31, there were 208 days of possible wildfire danger, with at least one region at Planning Level 2 or higher. Of the possible wildfire days, 123 were at Planning Level 2, 80 were at Planning Level 3, and 5 were at Planning Level 4.

On 28 days, at least one area was at Planning Level 3 while the rest of the state was at Planning Level 2. On 8 days, at least one area was at Planning Level 4 while the rest of the state was at Planning Level 3.

# Cache/Symbols Program

#### **Live Fuel Moisture**

Minnesota, Wisconsin and Michigan performed Live Fuel Moisture measurements for a study out of Missoula, adding three sites — Bemidji, Big Falls and Sandstone. All sites measure fuel moisture. Bemidji also measures fuel density.

### **Red Flag Warnings**

We continue to assess proposed changes to the Red Flag Warning. A proposal recommends adding wind gusts to the Red Flag Warning. Wind elements in the warning are sustained 20-foot winds of greater than 20 mph and/or "frequent" (generally three hours or more) of gusts of over 25 mph in wooded areas or more than 35 mph in grasslands (Red River Valley and SW Minnesota).

#### Information

Red Flag warnings in November received media attention, as did fire prevention activities for Smokey's Birthday and Minnesota resources on out-of-state assignments.

Activities also included creating a tips sheet for media covering fires and updatin YouTube, Twitter, and photo sites.

#### Cache

The Northeast Interagency Fire Cache processed and shipped 4,040 line items that totaled almost \$2 million, and 450 line item returns for over \$526. We shipped supplies to the caches in Boise, Northern California, New Mexico, and Colorado for a total of \$331,304.

NEK also supports the cache system nationally by refurbishing all the pumps for the Southern Area and the Rocky Mountain fire caches. The cache outfitted three Type 2 IA crews for out-of-state assignments. We provided supplies and equipment for two wildfire academies, four college training courses, and 20 other training sessions, along with providing supplies to nine contract helibases, three tanker bases, SEAT bases, and CWN bases. Sales to fire departments and purchase orders totaled \$70,286.

NEK staff supported western fire season by assisting as



National Symbols Cache National Symbols Caches processed 2,371 orders for sales of \$979,989 this year.

We currently stock 88 products and will soon be adding a new Smokey Bear magnet with graphics from Grand Prize winner of the National Garden Club poster contest.

We updated the shipping station to improve ergonomics in addition to other improvements to the warehouse.

We continue to move all products to recycled materials when possible. Over 50 percent of our products are currently made from recycled materials.

# **US Fish & Wildlife Service**

For the US Fish and Wildlife service, 2014 was an interesting and challenging year— an extended winter, continuing budget battles within DOI and workforce reorganization within the FWS, a record setting wet spring, and early snows this fall.

Even with a compressed fire season, reduced budgets, and a shrinking workforce, field stations were able to conduct over 210 prescribed burns for 30,210 acres (better than last year, but lower than average).

Field stations managed a dynamic fire season on FWS lands and provided incident support to local and MNICS partners on wildfires. No severity funding was requested for FWS lands in 2014.

Two new prescribed fire assistance agreements were completed between FWS and the Chippewa and Superior National Forests.

## **Personnel Changes**

#### **Training**

The FWS coordinated an S-234 class at the MNICS Academy and assisted with other courses. Interagency fire refreshers and other local courses were held at most FWS stations.

#### Mobilization

Over 43 FWS resources were dispatched to 7 different states this year. Personnel held positions in operations, aviation, plans, finance, dispatching, and command including several trainee assignments as BUYM, FACL, ICT4, ENGB, and CRWB.

# **Agency Reviews**

# Homeland Security and Emergency Management

#### Disaster assistance

In the spring of 2014, the Minnesota Legislature created a disaster response and recovery funding framework to improve our service to local communities. The dedicated Disaster Assistance Contingency Account covers the non-federal share of eligible expenses when the state receives a presidential disaster declaration. It helps counties that don't qualify for federal disaster aid, but whose eligible damages exceed the county's ability to recover on its own.

#### Rail and pipeline safety

In May of 2014, a railroad and pipeline safety law took effect calling for HSEM to work with local emergency managers and responders to help them understand the dangers of oil and other hazardous materials moving through the state. HSEM will help local units include emergency response information in emergency operations plans and work with railroad and pipeline companies to develop safety protocols.

#### June severe storms

The SEOC activated to Level III on June 16 and rose to Level II on

June 19 to respond to severe storms and heavy rain. The SEOC helped deploy resources, including sending the National Guard to Koochiching and Sibley counties. The SEOC remained activated for 44 days.

On July 9, Governor Dayton secured a presidential disaster declaration which included 37 counties and three tribal governments. Jurisdictions are eligible for FEMA Public Assistance, which will pay for emergency work, debris removal and repair or replacement of damaged infrastructure.

#### **IPAWS** gains momentum

A new tool is available for local officials when they need to advise residents to evacuate or shelter-in-place. The Integrated Public Alert and Warning System (IPAWS) allows local officials to send Wireless Emergency Alerts to newer model cell phones, providing instant notification to evacuate or shelter-in-place. **HSEM** staff members are helping develop policy guidelines for local officials. #### **Law Enforcement Support Office**

HSEM administers the Law Enforcement Support Office, which provides surplus military equipment to local law enforcement agencies. In FY 2014, LESO helped procure \$4.2 million in vehicles, weapons, clothing, office equipment and night vision goggles for 284 requesting jurisdictions.

## School safety center

Keeping our children safe at school is a top priority for HSEM. July 2014 marked the one-year anniversary of the reestablished Minnesota School Safety Center (MnSSC), an essential safety resource for schools, law enforcement, emergency responders and community partners. The center provides information, guidance, training and technical assistance. MnSSC teams traveled the state, observing school-related exercises, making presentations and providing training. They reached over 500 individuals in nearly 70 school districts and public safety agencies, for more than 2,000 contact hours in a sixmonth period.

# Minnesota Department of Natural Resources

Minnesota went into the 2013 fall fire season with dry conditions in northwestern Minnesota, but the 2013/14 winter helped to ease drought conditions with several areas receiving near record snow.

A cool, wet spring followed, which gave us a fairly quiet fire season for Minnesota Department of Natural Resources (DNR) firefighters. A quiet summer and fall led to a near record year for fewest wildfires and acres burned.

In 2014, there have been 465 wildfires (less than one-third of the average number of fires in a year). These fires burned 2,898 acres on DNR-administered lands, less than one-tenth of the average acres. Information on the fires and acres burned for all MNICS agencies is on p. 12).

Western states, however, had many fires. The DNR sent over 201 people to assist with out-of-state firefighting and support this year.

## Work capacity testing


DNR implemented a new work capacity testing system. The program includes a selfassessment Health Screening


Questionnaire. Minnesota's standard is the moderate level for state fires – two miles with a 25 pound pack in 30 minutes.

## **Fire Danger, Burning Permits**

The online burning permit program covers most counties

in the forested part of the state. It allows fire managers to control burning on a daily basis. Dispatchers/fire managers have the ability to view a map that shows the location of activated burn permits.





# **National Park Service**

## **Wildfire Prevention Program**

This past year the Minnesota Wildfire Prevention Program, working with the Great Lakes Forest Fire Compact partners, produced materials used for Minnesota public libraries' summer reading program in conjunction with Smokey's 70<sup>th</sup> birthday. Smokey visited over 60 libraries and provided fire prevention materials to over 190 libraries statewide.

In addition, DNR Forestry staff participated in many "Smokey Birthday" celebrations at DNR offices, schools and air bases.

Each year the DNR participates in Spring Fire Prevention Week activities and Fire Prevention Day at the Minnesota State Fair.

# Assisting rural fire departments

The DNR assists rural fire departments by providing or administering cost-share grants, technical assistance, low-cost equipment and wildland fire training through two federal programs.

Monument. Fire Season was
slow for the entire group.

At Saint Croix National Scenic Riverways, we were able to accomplish some prescribed burning this spring, completing five units for about 175 acres. And at Pipestone we completed two units for 100 acres with assistance from the Fish and Wildlife folks from Windom.

At Voyageurs National Park, like much of northern Minnesota, we dealt with flooding along. Several campsites and day use areas were closed for most of the summer, waiting for the waters to recede.

Apostle Islands National Lakeshore, while not a MNICS park, is part of the Border Waters Park Group. The NPS managed a wildfire on York Island. The Cedar Fire was detected on Aug. 21, 2014. It was active into early October.

Although acreage was minimal, this was the first time a fire was managed, instead of being fully suppressed, so it was a historic fire. Assistance was provided by the Bureau of Indian Affairs, and the Chequamegon-Nicolet National Forest, along with park staff and the National Park Service Midwest Regional Office.

# **Bureau of Indian Affairs**



The MNICS partnerships are the foundation for safe and effective wildland fire operations in Minnesota and throughout the United States. The Bureau of Indian Affairs and Tribal Fire Programs were proud to provide resources to assist with interagency incidents while also tending to the needs of the communities they serve.

#### Suppression

The 2014 fire season was quiet throughout Minnesota. Fire activity began in March and continued with minimal activity into early November. See chart, right for fire numbers for Red Lake Agency and the Minnesota Agency reservations.

In addition to fighting fires on their home units, BIA and each tribal fire program provided off-unit support on incidents both in Minnesota and out of state. These assignments included support in fire, fire severity, fire preposition, initial attack, prescribed burning, fire planning, wildfire use, fire investigation, fire prevention, dispatch support, aviation, MNICS Incident Management Team assignments and teaching fire or NWCG courses.

#### **Aviation**

It was a quiet year for fires. Neither of the CL-215 Tankers were used for wildfires on reservation lands.

# **US Forest Service**

#### Wildland Fires

A cold and wet spring led to a very quiet fire season that carried through the summer and into the fall. The number of fires and acreage are some of the lowest totals in many years.

The Chippewa National Forest's fire season began April 18. There were 24 fires for 92 acres. The largest fire was 36 acres on the Walker Ranger District, in lowland grasses and hardwoods.

The Superior National Forest's fire season began April 28.
There were 20 fires for 32 acres.
The largest fire was 14 acres on the Kawishiwi Ranger District.

Both the Chippewa and Superior National Forests sent resources to help partners with prescribed burns and wildland fires. We were very active in regional and national support throughout the 2014 fire season with our Type III helicopter, Type 2 IA crews, engines and overhead resources.

#### **Prescribed Fire**

The Chippewa National Forest had a challenging prescribed fire program in 2014, completing 15 prescribed burns for 3,500 acres. The Superior completed 1,840 acres with 103 prescribed fires. The program continues into the

fall and winter with pile burns. These prescribed fires would not have been possible without assistance from MNICS partners. Thank you for the cooperation.

# Information Management

# GIS

Geographic Information System (GIS) response has been nonexistent this year with no IMTs activated in state, and very few incidents where we could provide training and development.

## **Finance**

It was a relatively slow year for the Finance WT this year. Randee Olson went west on multiple assignments, but most of us relaxed and planned for next year.

One Finance WT member, Kevin O'Brien, went to Colorado for a train-thetrainer class on e-ISuite, the software IMTs use to track resources in the Finance and Plans sections. The program is scheduled to be available April 1, 2015.

The change will not be dramatic for the Operations section, but Plans, Finance and even Logistics will see significant change.

The e-ISuite internet version of ISuite has been in the works for many years. Beginning Jan. 1, 2015, training modules will become available. A practice database has been developed. There will be training videos on process and keystrokes for each module.

On April 1, teams and hosts will be able to start using e-

ISuite. Both e-ISuite and ISuite will be available. Using the new e-ISuite is optional, but is recommended.

Two interesting points: First, not everyone will have to be in fire camp. For example, if there are more timesheets than one person can do, CTRs can be scanned and emailed to a Time Recorder 100 miles away, who enters the CTRs and goes home at the end of shift.

Second, when the team leaves, the database will still be available to the local host. Costs and demobilizations can continue to be entered. The local supervisor will continue to have access to the latest information on the fire.

The last note is that ISuite will go away in 2015 or 2016. Thank goodness I saved my copy of the 1993 ICARS. I'll share it with anyone who has Windows 3.1 and a 5" floppy.

## Prescribed Fire/Fuels



This past year, the Prescribed Fire and Fuels Working Team (PFFWT) focused on revising the Minnesota Smoke Management Plan (SMP), along with a few ongoing projects. New members of the team are: Cassie McMahon and Lisa Herschberger from the MN PCA, and Isaac Heruth and Lori Karau from the Superior National Forest.

SMP revisions should be done by January 2015. The last major revision was in 2008. Significant changes are: update air quality regulations and wildland fire terminology, and add documentation to prescribed fire reporting.

The SMP's purpose is to mitigate nuisance and public safety hazards due to smoke intrusions into populated areas, prevent decline of air quality, avoid National Ambient Air Quality

Standards violations, and address visibility impacts in certain airsheds.

Each year since 2003, the PFFWT has collected prescribed burn data from participating agencies and shared the information with the Minnesota Pollution Control Agency (MN PCA). Data from burns and air quality monitors are used to assess prescribed fire effects on air quality.

To date, no violations of national air quality standards for ozone or particulate matter have occurred because of prescribed fire or other managed wildland fires in the state. As prescribed fire use increases, SMP compliance will help prevent adverse impacts to air quality.

The PFFWT has beenworking with the MN PCA on prescribed fire reporting requirements to

streamline and simplify reporting.

The team is assessing proposed changes to the Red Flag Warning criteria. (Proposals are in bold.) The Red Flag Warning wind elements are: sustained 20 foot winds of greater than 20 mph and/or "frequent" (generally 3 hours or more) gusts of greater than 25 mph in wooded areas, or greater than 35 mph in grasslands (Red River Valley and SW MN). Adding gust criteria will more accurately reflect actual fire danger.

North Arm of Burntside Lake. It
was a great opportunity to see
these treatments firsthand.

# **Training**

Workforce Analysis: This continuing project analyzes current Incident Management Team (IMT) positions and members. It color codes each person by approximate years to retirement and indicates trainees and feeder positions to named team positions. Updated annually, the analysis shows the MNICS Task Force and Board of Directors how we are managing our IMTs as employees retire and new folks advance.

**Priority Trainee Program:** This was the eighth year for the MNICS priority trainee program. During the past year, 112 people applied to the program.

Training Needs Assessment: The annual training needs assessment takes place in August. Results are posted on the MNICS website. This tool helps in planning for training for the next two years. The results also go to the Northeast Region so the Eastern Area Training Working Team is aware of the higher-level training needs that MNICS cannot meet locally.

**Training Accomplishments:** In 2014, MNICS offered 34 fire training courses, with 1,151 student registrations, and worked with Advanced Minnesota to host the 14<sup>th</sup> Annual Minnesota Wildfire Academy. The academy registered a record 698 students for 26 fire courses. Attendees came from MNICS agencies, fire departments, contractors and federal and state agencies across the Midwest.

**2015 Planned Training:** The Training WT is setting up training for 2015 and planning for 2016. (See box, right.)
