Nick Able – handed out summary of 2018 activity. Difficult to roster crews 2018.

Reasons for this include:

AD issue USFS working to address problem. AD class is for local forest needs. USFS is working to address AD for National resource surge needs. (info from John Agner)

DNR supervisor approval for more than 1 or 2 assignments is difficult ICT5 shortage this is a staff shortage, also a national issue USFS timber militia not available

What opportunities are there to get more interest in crew assignments

Furr – fire use module can be an oppourtunity. He is putting one together with his staff Gotchie – Name ICT5(t) on crews

Able – move toward a pool system for leadership

It was decided to try and do a presentation at appropriate classes at Academy and other times those courses are offered.

Using NER for rental is quite expensive

Michigan has used these well, some issue with security as no locked storage available.

In 2018 no performance issues with crews.

Always some issues with fitness – has been a problem always. Wherley solution – just don't accept Pansies

Ryan Miller – option for permanent T2IA crews. SD state has used grants to fund crews and has been successful. Interagency portion would be difficult if it is a state crew, but a crew shell could be hired and filled out with Interagency staff to make a 20 person crew.
