The MNICS Taskforce is now accepting applications for the 2026 Minnesota Type 3 Incident Management Teams (IMTs). These interagency teams play a vital role in managing wildfires and responding to all-hazard incidents across Minnesota throughout the year.

By joining a Type 3 IMT, you'll gain valuable hands-on experience in incident management from the outset. Our teams are built on strong, professional collaboration among members, partners, and stakeholders—an essential foundation during emergency operations. We're seeking leaders who foster team strength, unity, and inclusivity while mentoring and guiding others effectively.

Local Deployment Periods

MNICS Type 3 IMTs operate locally during two key periods: Spring: April 1 - June 15 and Fall: September 1 - October 3. These timeframes may be adjusted by the MNICS Taskforce based on in-state fire conditions.

National Deployment Outlook

MNICS has a strong track record of successfully rostering and deploying Type 3 IMTs for national assignments. As demand for experienced teams continues to rise, Type 3 support remains a critical component of effective incident response nationwide.

Looking ahead to 2026, MNICS will evaluate opportunities for national availability during the peak period of June through August. The MNICS Taskforce, in coordination with team Incident Commanders, will carefully manage deployment schedules to ensure Minnesota's operational needs are met before committing teams to national assignments.

Who Should Apply

We welcome qualified and trainee candidates to apply for any team position. Applicants may apply for both primary and alternate roles. Additionally, we encourage interest in discretionary positions, which provide vital support to the team when needed.

Selected IMT members will serve a one-year term, with the opportunity to reapply annually for continued participation.
