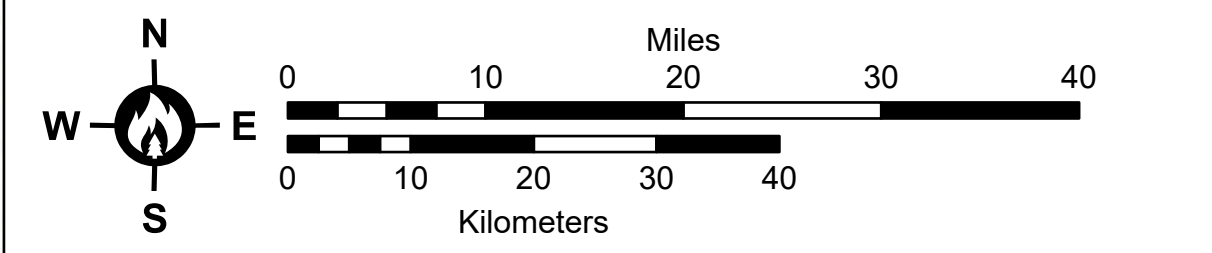


Statewide Aerial Hazards 2026
